SUBJECT: THE 2010 CULTURAL COMPETENCE PLAN REQUIREMENTS

REFERENCE DMH INFORMATION NOTICE NO. 02-03

The Department of Mental Health (DMH) is issuing the enclosed revised 2010 Cultural Competence Plan Requirements (CCPR). The 2010 CCPR is DMH's mechanism to expand and integrate cultural competence from Specialty Mental Health Services to the entire mental health system. This CCPR supersedes previous Information Notice 02-03 and goes into effect immediately.

"Small Counties", as defined by Title 9, California Code of Regulations, Section 3200.640, shall complete and submit a 2010 CCPR Modification, pursuant to the DMH Information Notice that will follow this notice; however, small counties can opt to complete this full 2010 CCPR.

Counties will have six months from the release of this Information Notice to complete their 2010 CCPR. During those six months, DMH will offer regional Technical Assistance Training to counties. The 2010 CCPR will be due to DMH on July 28, 2010. County CCPR submissions will be reviewed and scored by DMH. Please submit one original, three copies, and one compact disc of the document saved in PDF (preferred) or Microsoft Word (1997-2003) format to:
